RECYCLING OUR LIFESTYLE

- Did you know
- In less than 1 hour the U.K Produces enough waste to Fill the Albert Hall.
- It takes just 25 2 litre plastic pop bottles to make 1 adult fleece jacket.
- We now use 20 times more Plastic than we did 50 years ago

Just think we throw away our own body weight in rubbish every 7 weeks. That's an awful lot of rubbish and up until now we have been putting all this into big holes in the ground. Its not just Milk and fizzy drinks that come in Plastic bottles, lots of other things do too-and recycling them all is important.

Have a hunt around the house and you'll see there's a range of things from shampoo and conditioner bottles to washing – up liquid, hand soap and even car screen wash are all waiting to be saved. A little action like recycling just one plastic bottle can power a 60 watt light bulb for 6 hours or a computer for 25minutes.

At the moment the Caerphilly County borough Council are operating a fortunately curb side collection service in the village and they will collect Glass, Tins, Aluminum cans, newspapers/ magazines and Plastic bottles.

The green waste Collection:

This is all your grass cuttings and small hedge clippings.

Next collection date: 8,15,22 August and fortnightly there after

Why do I have to wash out jars and tins for recycling.

TO STOP IT CONTAMINATING THE RECYCLING PROCESS AND KEEP YOUR BIN CLEAN.

Do I need to remove the labels from the plastic/ glass bottles and cans.

NO THEY WILL BE REMOVED DURING THE RECYCLING PROCESS.

Do I need to remove the tops of plastic bottles.

YES THE TOPS ARE SOMETIMES MADE FROM A DIFFERENT MATERIAL TO THE BOTTLES AND SO CANNOT BE RECYCLED THE SAME PROCESS. IT CAN ALSO MAKE IT DUFFERCULT TO FLATTEN THE BOTLE AS IT IS FULL OF TRAPPED AIR.

How can I tell if a metal container is Aluminium .

ALUMINIUM CANS ARE OFTEN MARKED A.L.U. TYPICALLY SOFT-DRINKS, BEER OR CYDER COME IN ALUMINIUM CANS. STEEL CANS ARE EASILY DISTINGUISHED, BECAUSE THEY ARE MAGNETIC . MOST FOOD TINS ARE MADE FROM STEEL

RATS

There is little appealing about this pest in the home. Rats are mammals distinguished by their large incisor teeth. The greatest worry to humans and animals comes from the fact that rats are capable of transmitting disease- everything from Salmonella poisoning to Dysentery and Gastroenteritis. If conditions are right Rats can quickly reach plague proportions very quickly.

A female Rat are capable of re-producing at just 3 months of age.

News from the Graig y Rhacca neighbourhood housing office

I am grateful to the Environmental and Conservation Group for asking me to contribute to their latest newsletter.

It gives me the opportunity to update you on some recent staff changes at the neighbourhood Housing Office and to draw your attention to some other current issues.

Firstly many of you may have already met Leigh Lloyd the new maintenance officer, he joins the Graig y Rhacca staff, having transferred from the Gifach Neighbourhood Housing office where he had worked for the past 2 1/2 years. He has previously covered staff absence here in Graig y Rhacca and worked in Lansbury Park, so he may be familiar to some.

The recent Housing re-structure has created closer links between Caerphilly Area Housing Office; Lansbury Park and Graig y Rhacca NHO and Frances Hughes, clerical officer, who many of you do know and who has worked at Graig y Rhacca since 2001, will now be working both here and Lansbury Park. Spending 2 1/2 days in each office.

Tracy Heron has joined the staff and will take over Frances role on reception and as repairs contact. Again like Leigh she has worked in several other offices including Gilfach and Lansbury NHO, and will be happy to help and assist with any queries.

The post of Community Environmental Warden has been made permanent and Neil Box has been in post for some time. I would advise that his role is not simply to remove unwanted items for residents but to provide advise on appropriate council services and in liaison with the Housing Office to assist as necessary.

This leads me to more serious issues regarding the potential for breach of tenancy where gardens are not maintained to a reasonable standard and where rubbish is allowed to accumulate. It is my intention that Norma Millington, Housing Officer, is to continue with a programme of garden inspections; speaking and writing to tenants where it is felt action is required to bring gardens up to a required standard. Tenants will be given timescales in which to make an improvement, and advise and assistance will be available as appropriate. The housing office will lend strimmers to tenants free of charge on production of a rent card to assist with garden maintenance.

Even through the recent bad weather the NHO is getting complaints about loud music that is causing a nuisance to others and I would remind tenants that this is also a potential breach of tenancy. I would ask people to be mindful that everyone has different tastes and music that can be heard outside of your property and may be a nuisance to someone, so please keep the volume down.

On a lighter note I was pleased to support the Communities First Consultation programme, attending the Open day at the Resource Centre and Fun Day in the Community Centre, both of which were well attended and the results of the consultation will inform the Local Action Plan.
